Adult Programs - Most of the Organization's group course students are adults with day  
jobs, people who want to have music be part of their lives but who are not planning to  
become professional musicians. In 2024, 407 Adults particpated in 11-week group classes  
Private Music Lessons in 2024 were offered to 466 adults and  
231 youth taking guitar, piano, ukuklel, bass, drums and DJ-ing lessons.  
In 2024, 606 toddlers & their parents were served in Little Bear classes  
in parks and schools

WORKSHOP PROGRAMS: BAND WORKSHOPS, ALL STAR BANDS, SUMMER CAMPS

Summer camps in 2023 had 55 youths enrolled in week-long music day camps during  
the summer. Kids can be enrolled in Blue Bears week-long music day camps which  
run Monday through Friday and include a special performance on Friday ending. The  
camp curriculum was designed by renowned educator and artist Bonnie Hayes. Adult  
band workshops had 33 young musicians rehearsed and performed in 7 bands.  
All Star Bands in the fall of 2024 expanded to 46 youth in 10 differnent bands.  
134 adult musicians rehearsed and performed in 39 different bands in 2024
